**APPROVED MAXIMUM PROPERTY TAX
DOLLAR FOR FY 2024**

Whereas, a public hearing concerning the proposed city maximum property tax dollars was held on February 13, 2023.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Fostoria that the maximum property tax dollars for the affected tax levies for FY2024 shall not exceed the following total:

The Maximum Property Tax dollars requested in the total maximum levy for affected property tax levies for FY2024 does represent an increase of greater than 102% from the Maximum Property Tax dollars requested for FY2023/24.


It was moved by Council Member Rutter, seconded by Council Member Elsenbast **to approve a Lien 310 1st St SW - Chad Tuttle.**
