A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FOSTORIA, IOWA, SETTING SALARIES FOR APPOINTED OFFICERS AND EMPLOYEES FOR FISCAL YEAR 2023/24

BE IT RESOLVED, by the City Council of the City of Fostoria, Iowa:

1. The following positions names shall be paid the salaries and wages indicated and the Clerk or Mayor or Mayor-Pro Tem (two signatures required) are authorized to issue checks, less legally required or authorized deductions from the amounts set out below, and make sure contributions for FICA, MEDICARE and IPERS or the purpose as required by law or authorized by the Council, all subject to audit and review:


There being no further discussion, it was moved by Anderson, seconded by Elsenbast to adjourn the meeting at 8:45 P.M.
