**AMEND ORDINANCE NO. 96.02  
SEWER PERMIT AND CONNECTION FEES**

**BE IT ENACTED** that after due consideration by the City Council of the City of Fostoria, Iowa, Amend Ordinance 96.02 was adopted follows:

**ORDINANCE 96.02 PERMIT FEE AND CONNECTION CHARGE.**

Before any permit or connection is issued the person who makes the application shall pay a permit fee in the amount of fifty dollars (\$50.00) to the Clerk to cover the cost of issuing the permit and supervising, regulation, and inspecting the work. In addition, there shall be a connection charge in the amount of one hundred dollars (\$100.00) paid to reimburse the City for costs borne by the City in making sewer service available to the property served.

**WHEN EFFECTIVE:** This ordinance shall be in effect from and after its final passage, Approval of the City Council.

**AMEND ORDINANCE NO. 90.06  
WATER PERMIT AND CONNECTION FEES**

**BE IT ENACTED** that after due consideration by the City Council of the City of Fostoria, Iowa, Amend Ordinance 90.06 was adopted follows:

**ORDINANCE 90.06 WATER PERMIT AND CONNECTION FEES.**

Before any permit or connection is issued the person who makes the application shall pay a permit fee in the amount of fifty dollars (\$50.00) to the Clerk to cover the cost of issuing the permit and supervising, regulation, and inspecting the work. In addition, there shall be a connection charge in the amount of one hundred dollars (\$100.00) paid to reimburse the City for costs borne by the City in making water service available to the property served.

(Code of Iowa, Sec. 385.84)
